Available for up to four dependent children.

Individual or extended funeral cover

You can cover yourself as main life insured, along with additional insured lives such as parents, parents-in-law and up to two domestic workers.

Optional cover: Professional fees

- The Professional fees benefit covers the cost of professional service providers who assist in settling or unbundling estates, wills and trusts for the main member and spouse. Such providers include lawyers, executors or tax experts.
- The benefit is payable to the nominated beneficiary.
- This benefit only applies up to the age of 65.

Cover escalation

- Every year upon renewal of the main policy, benefits shall increase by 4% and premiums by 8%.

Ongeluksdekking

- In the event of accidental death, **DOUBLE** the cover amount for the Funeral Cash Plan and Professional fees will be paid out for any life insured under the policy, **without any waiting period**, provided that the first premium has been received.

Payment of claims

- We ensure payment of valid claims within two business days after all relevant documents have been received. As proceeds are received outside the deceased estate, money will be available immediately, provided that a beneficiary has been nominated. All claims must be submitted to Assupol Life **within six months** from the date of passing.

Waiting periods and exclusions

- There is a **six-month** waiting period for death due to natural causes. In case of accidental death, there is no waiting period, provided that the first premium has been received.
- Cover for death as a result of suicide is excluded for **12 months**.
